In follow up to the discussions at PCH Leadership on March 29, 2018, there is potential that a 0.25% efficiency target may be implemented within the personal care home sector. Although formal approval to proceed from Manitoba Health, Active Living and Seniors (MHSAL) has **not yet been received**, similar to the process followed last year, it is requested that each PCH complete the attached template to outline your proposed plan to achieve the 0.25% efficiency target, if approval to proceed is received from MHSAL.

The due date for submission of this plan is **Monday, April 16, 2018.**

Many ideas have been shared among the group in relation to potential actions that can be undertaken by PCHs to achieve the outlined savings target. Although plans to achieve the savings are left to the discretion of PCHs (understanding that plans should not impact quality of care to residents and overall safety) each site is encouraged to examine saving opportunities that can be planned, executed and achieved onsite (ex: vacancy management or administrative efficiencies) and do not require other approvals in order to achieve, such as MHSAL approval for position deletions.
